Request for Proposal: Project Kiana, Phase I Environmental Site Assessment December 16, 2024

### **Executive Summary**

Westchester Land Trust seeks a proposal for a Phase I Environmental Site Assessment (Phase I ESA) on approximately 2.85 acres on the west side of the Hutchinson River Parkway in Mount Vernon, New York. The Phase I ESA and report must comply with or exceed ASTM E1527-21 and be overseen by a Professional Engineer or Professional Geologist licensed in the State of New York.

The Project Kiana area is owned by the New York State Department of Transportation and managed as excess land. The Phase I Environmental Site Assessment is part of a larger initiative to determine if the potential exists to purchase, protect, or otherwise manage the property to restore the urban riparian forest or provide meaningful community connections.

The NYS DOT granted Westchester Land Trust a permit to access and collect data on the project site. Compliance with the permit is required.

## **Property Description**

The Project Kiana area is a highly deteriorated urban riparian forest. Little to no native understory exists, and some areas are dense with invasive species.

The property is bound to the east by the Hutchinson River Parkway, to the north by the Metro North Railroad, and residential properties on the south and west. The property includes an oxbow of the Hutchinson River.

The property is located south of Westchester County's Wilson Woods Park, which can be accessed by walking on an informal foot path along the barriers of the Hutchinson River Parkway.
